South Lakeland Economic Growth Strategy	Sets out priorities for promoting economic growth in South Lakeland	April 2014	Very dated but requires updating on a WFC footprint
South Lakeland Equality, Diversity and Inclusion Strategy (formerly scheme);	sets out how SLDC District meets requirements of public sector equality duty including equality objectives.	December 2018	WFC will need to comply and demonstrate compliance with 2010 Equalities Act – single approach needed. Matter for shadow authority

South Cumbria Community Safety Plan	Produced by South Cumbria Community Safety Partnership and covers South Lakeland and Barrow. Sets priorities for Community Safety across South Cumbria	March 2019	New authority will need to review Community Safety Partnerships including whether to align CSPs on a Westmorland and Furness basis. Eden are currently in a North Cumbria CSP with Carlisle.

South Lakeland Local Lettings Policy	Sets out Local Connections requirements for former SLDC Council Houses now owned by South Lakes Housing	August 2012	Specific to South Lakeland and South Lakes Housing properties. May need to harmonise approach with Eden in the longer term. Only applies to smaller settlements.
South Lakeland Licencing Policy	Sets out basis for making decisions under the 2003 licencing act	January 2016	Review pending – WFC will need consistent policy
South Lakeland Medium Term Financial Plan	Ensures the Council has sufficient financial resources in the short-to medium-term (5 years) to deliver its statutory responsibilities and its Council Plan priorities.	March 2021	March 2022 MTFP will be the last for South Lakeland. It will be superseded by a MTFP for Westmorland and Furness.
